RESPONSIBILITIES OF PARENTS

- Take an active part in all school fundraising activities.
- Be responsible for all damage and loss of school property caused by the student.
- Follow the approved chain of command whenever a problem arises in the classroom. Discuss the matter with teacher, then the principal, then the pastor, and finally the superintendent.
